It is NOT against a regular post, but on contract basis only. The contract will stand automatically terminated at the end of the period, unless intimated otherwise in writing. GSL does not provide any assurance for regular employment on completion of contract tenure.

*Note 2: 70% of the consolidated pay will be considered as Basic pay for calculation of statutory benefits as applicable.

#Note 3: Only Post Qualification Experience will be considered. Apprenticeship training in any industry shall be considered as experience for applying to the post of JPE.

I. Educational Qualification for Engineering Discipline:

Lateral Entry to 3rd Semester of 8 Semester course / 2nd year of 4 years course will also be considered as equivalent qualification.

- **III.** Post graduate integrated Degree Courses will also be allowed for Engineering disciplines in Technical posts. The integrated Professional Technical qualification should be of 5 years duration after 10+2 qualification.

IV. CRITERIA FOR SELECTION:

The selection process will consist of Written Test, Document Verification, Group Discussion / Interview.

- i. **WRITTEN TEST:** The Written Test will normally consist of 25% General Aptitude and 75% subject/trade related questions. Candidates need to secure minimum 40% marks for General/EWS category and 35% marks for SC/ST/PwBD/OBC category to qualify for the subsequent stage of selection. The written test may be conducted through Computer based Test (CBT) or Pen Paper based Test (PBT).
- ii. **DOCUMENT VERIFICATION:** A category-wise list will be drawn of the candidates who qualify the written test. In case of large response, candidates in the ratio of 1:5 based on the performance in the written test shall be called for the Document Verification followed by Group Discussion / Interview. These candidates shall produce all the relevant documents in original at the time of Document Verification. Further, candidature of a candidate is liable to be rejected at any stage of the recruitment process or after recruitment or joining, if any information provided by the candidate is found to be false or not in conformity with the eligibility criteria mentioned in the advertisement.
- iii. **GROUP DISCUSSION / INTERVIEW:** The candidates, who clear the Document Verification round, shall only be eligible for the Group Discussion /Interview. Candidates need to secure minimum 40% marks for General/EWS and 35% marks for SC/ST/PwBD/OBC to qualify.

iv. **FINAL GRADING:** On completion of written test, group discussion / Interview, the weightage of final grading marks will be out of 100% as mentioned in the table below:

Note: Merit list for each post shall be prepared based on marks secured by the candidates meeting the notified eligibility requirements and who pass written test, group discussion / interview and has cleared the document verification. In case, same aggregate marks are secured by more than one candidate, marks scored in the group discussion /Interview will be the basis for determining the order of rank list. In case of a tie in group discussion /Interview marks as well, relative merit shall be decided based on Written test marks, further in case of tie, seniority in age will be considered for determining the order of rank list.

V. AGE CRITERIA & RELAXATION:

- i. The upper age limit for eligibility against the post has been specified above.
- ii. Relaxation in age will be granted to SC/ST/OBC(NCL)/Ex-Servicemen/Agniveers and PwBD candidates as per existing Government guidelines.
- iii. Candidates who have completed Graduate Apprentices or Advance trainee in GSL will be provided age relaxation upto the number of years as Apprentice/ Advance trainee in GSL.

VI. PLACE OF POSTING

The posting shall be at GSL/any other GSL unit's/project sites as desired by GSL. However, depending upon project requirements, the candidates are liable to be transferred within different units of GSL. The appointment to the post carries with it the obligation to serve in any department of GSL or on-board ships or in any of the unit's / work sites/ projects undertaken in any part of India or abroad as the case may be.

VII. <u>RESERVATIONS:</u>

- i. Candidates from reserved category fulfilling eligibility criteria may also apply for the posts earmarked for UR as per Govt. Rules. Such candidates applying for a post where there are no vacancies in their respective reserved categories will be treated as General candidates and no relaxation in any criteria will be applicable to these candidates.
- ii. Candidates from reserved category will have to submit caste certificate, in the Prescribed Proforma meant for "Appointment to posts under the Government of India" from the designated authority indicating clearly the candidate's caste, the Act/Order under which the caste is recognized as SC/ST/OBC (NCL) and the Village/Town the candidate is ordinarily a resident of. The OBC (NCL) certificate should not be more than 06 months old at the time of joining. Candidates under PwBD category will have to submit the disability certificate from the designated authority as stipulated in Rights of Persons with Disabilities Act, 2016 indicating

clearly the percentage of disability. Candidates from EWS category will have to submit the EWS certificate from the designated authority for the Financial Year 2024-25.

- iii. If the SC/ST/OBC (NCL)/PwBD certificate has been issued in a language other than English/Hindi, the candidates will be required to submit a self-certified translated copy of the same either in English or Hindi. GSL reserves the right to verify the genuineness of the certificate and in case it is found to be false penal action will be taken against such candidates as per rules of GSL and Government guidelines as applicable.
- iv. Ex-Servicemen can also apply against the advertised posts subject to fulfilling the eligibility criteria. Their candidature will be considered as per Government guidelines in vogue.
- v. Concessions & relaxations will be granted to PwBD candidates applying against the said posts. Their candidature will be considered as per Government guidelines in vogue.

VIII. GENERAL CONDITION

- 1. The candidates are advised to make sure that they are meeting the eligibility requirements as per the vacancy notification for the posts before submitting the applications.
- 2. The candidates may note that the applications are to be made through online application system as per the instructions given. Applications made in any other manner shall not be considered and shall be summarily rejected. Management will not be responsible for any application which is not received through online system.

- 6. There will be no transfer of service benefits from previous employment to GSL or pay protection, in view of the same No Objection Certificate (NOC) will not be mandatory for the candidates who apply against Project Executive posts. However, in case of selection, proper relieving letter should be produced by the candidate before joining.

- 7. Management reserves the right to fill or not to fill the post/s and also to fill up future vacancies, if any, from the valid panel of selected candidates as per the rules of the company. GSL Management in its sole discretion reserves the right to increase / reduce the number of vacancies notified. - ➤ Passport size colour Photograph with light background (preferably white) without any obstacle covering/obstructing the face and eyes. Size of the file should be below 450 kb.
- ➤ Candidate's signature should be on a plain white paper with black ink. The signature should not be digitalized. It should be scanned copy of your own signature on paper with pen. Size of the file should be below 450 kb.
- > Scanned copy of SSC certificate as proof of date of Birth not more than 500 kb in size.
- Scanned copy of Educational qualification mark sheet & degree not more than 1 MB.
- Scanned copy of Caste/Disability certificate not more than 500 kb.
- Scanned copy of experience certificates not more than 1 MB.
- Scanned copy of Aadhar Card not more than 500 kb.
